#### Returning to the worksite

Employees are concerned and anxious during this time. All screeners will be equipped with appropriate personal protective equipment (PPE). Optum will work with each employer to develop a plan for managing traffic flow to get employees screened as promptly and safely as possible. If an individual is presenting symptoms or identifies as a possible carrier of the virus, your company policies and resources dictate the actionable steps.

#### **Employee experience**

Optum On-Site Health Screenings can be tailored to meet the unique needs of your worksites.

Employees arrive at the worksite and are guided through the screening process, while maintaining proper physical distancing protocols.



The Optum clinical screener, protected in PPE, is stationed at each worksite entrance that is accessible to employees. Employees are required to have a screening conducted prior to entering the facility.





Screener verbally completes a short questionnaire with each employee to address any potential symptoms of COVID-19 or recent contact with an individual who has been diagnosed with the virus.

After completion of the questionnaire, employee temperature is taken via a nontouch temporal scanner by the clinical screener and recorded.



If no risk is detected based on questionnaire and temperature check, employee proceeds into the facility.



If risk is detected based on questionnaire and/or temperature check, next steps are dictated by company policy.
